## **General Community Updates**

#### 2015-2016 Board Accomplishments-

**Grass Clippings** – Following a mowing operation, grass clippings must be removed from the paved surfaces. It is a city ordinance. Whereas the Ravenna HOA has jurisdiction over the driveway, the City of Chesapeake has jurisdiction over the sidewalks and roads. If left on the driveway, the homeowner will receive a violation. If clippings are left on the sidewalk or road, the homeowner will be reported to the City and the HOA will follow-up on its action.

#### **Trailors, RVs, and Boats**

Please remember to adhere to the Ravenna guidelines regarding trailors, rvs, and boats. Article VI, section 6.01, Q- Outside Storage: No commercial or recreational vehicles, including but not limited to, school buses, boats, campers, or trailors, shall be parked or stored in front of the front house line, upon the public streets in front of the home, or anywhere upon the Lot in Ravenna.

#### **Architectural Approval**

There are certain improvements to houses that require approval from the architectural standards committee. The application can be found on the Ravenna website. The following items <u>DO</u> require approval by the ASC: any above surface utilities, awnings, decks, fences, permanent screening areas, driveways, sidewalks, courtyards, exterior modification of home/room additions/story additions, flag poles, foundations, hurricane shutters, **major** landscape modifications, swimming pools, hot tubs, sheds, garages, pergolas, gazebos, outbuildings of any kind, sunroom additions, and solar conductors. Failure to submit an application or wait for approval prior to starting a project may result in fines. Approval from the committee does not alleviate the need for any approvals or permits by the City of Chesapeake, if required.

**Gun Shots Behind Ravenna** - Hunting is now prohibited in the wetlands between the Ravenna subdivision and the Intercoastal waterway. Report rifle shots from hunters to Chesapeake Police at 382-6556.

**Speeding** – Speeding in Ravenna demonstrates a disregard for the safety of others and continues to be an issue. <u>SLOW DOWN</u>. The Chesapeake Police have been alerted to this situation.

**Street Parking** – If folks continue to park on the street rather than in their driveways, particularly along Ravenna Course, it is just a matter of time before a child steps out from in front of a parked car into the path of a speeding vehicle. For this reason, homeowners and renters are highly encouraged to park in their driveways.

**Fireworks-** Please be considerate to your neighbors when shooting off fireworks multiple days in a row near a holiday. There are many pets, young children, and military personnel with PTSD that live in the neighborhood that are drastically affected by the noise.

#### Problem Lawns -

Yards are continuing to be a problem for our community. Be mindful of weeds, edging, and grass thickness. The regulations are in place in order to continue to maintain the high quality of the Ravenna neighborhood.

#### **Status of the Bradshaw Property**

In response to Ravenna's query as to the possibility of acquiring 3.5 acres of the Bradshaw property, we received the following from the city: The first step for the long term disposition of properties acquired to protect military installations is to see if the US Navy is interested in purchasing a conservation easement under their Readiness and **Environmental Protection Integration (REPI)** program. The Navy is currently evaluating the properties recently purchased around Fentress and we hope to hear back from them later this spring. If the Navy does not purchase an easement, the City departments will evaluate for public use and then present to City Council for approval. The last resort option is to sell or lease. That would be after an open bidding process for potential buyers or leasers. If the properties were to get to this option, you would submit your proposal along with others who may be interested in the property. Whatever option is selected, a public hearing is required for City Council approval.
